PUPPY WARRANTY

The adopter certifies having received the health, vaccination and deworming booklet upon pick up of his new puppy. The adopter declares accepting his new puppy with all its characteristics (color, mask, teeth, eyes, etc.) as well as the possible remarks in the health booklet.
